# Introduction to the Drama Department

## Staffing

Welcome to the Drama Department, we are a highly dedicated and successful department delivering a comprehensive and diverse curriculum to students in all Key Stages, as well as providing a wide range of extra-curricular opportunities. We currently have four teachers in the department. We are part of the wider Expressive Arts faculty, including Music and Dance.

## Accommodation and Resources

We have superb new facilities for Drama which consist of three large studios, changing rooms, and a 200 seat theatre. We have a range of lighting and sound equipment at our disposal which we use to enrich our lessons as well as allowing us to produce several professional quality small and large scale productions each year. We also have a large bank of play-texts, set items, props and a costume store to support our teaching. Curriculum Drama is taught to all students in KS3 for an hour per week. It is also a very popular option at GCSE and in Post 16 through A Level Theatre Studies and BTEC Performing Arts. The focus of the KS3 curriculum is to build performance skills and techniques in the foundation years to enable students to fulfil their potential in this subject. At GCSE and A level we follow the AQA syllabus. We also run a BTEC Performing Arts, Level 3 course. Opportunities are also provided for students to experience specialised workshops and on site performances.

## Results

The progress and attainment of our students is good. Our GCSE Drama results have remained above the national average for many years and we pride ourselves on consistently bettering national gender gap trends. We will be looking for an applicant who can engage and inspire our students and who recognises the value and impact of providing exciting enrichment opportunities.

## Extra Curricular

There is a huge commitment within the department to provide enrichment opportunities for students outside of lessons in the form of theatre visits and college productions. The department also offers various clubs where students can experience more drama, musical theatre and the technical aspects of staging a performance. We are fortunate to have dedicated Performing Arts technician who supports the technical aspects of the work we do.

The College is currently seeking a qualified teacher to take on a role teaching Drama. The successful applicant will be expected to provide outstanding teaching and learning of Drama to ensure high attainment of students. The post holder will adhere to the professional duties of a teacher as set out in the School Teachers' Pay and Conditions of Service document and College policies.
